2. Approval of Minutes from the meeting held on Monday, November 6, 2023

- C. Master Comp Plan 2023 update Ms. Prebis stated we have a study group meeting on Wed, Jan 24 at 6:30pm. Also, Simone Collins came to the township today to do "key person interviews" of all the Park and Recreation staff. She stated there were about 120 answers to the CRPOS survey and the P & R board came up with some ideas on how to get the word out: QR code in park, on bottom of emails, or on bottom of registration emails. A post card could go out with QR code towards the end if we are lacking in survey responses.

6. **New Business**

A. Spring Events:

- 1. <u>Bag Bingo</u> Fri, April 5, 2024. We have venue and have contacted DJ. We are looking for 3 4 volunteers. The Small Games License was discussed and had been applied for by the P & R staff. Kids attending was also discussed and Ms. Prebis referred to the license and the minimum age is: 18. Under 18 is permitted to attend but may not play any BINGO games.
- 2. Golf Outing Mon, April 15, 2024. P& R is in a dilemma. We are choosing between 2 golf courses. Do we go with the more prestigious one OR the cheaper one? The majority said the most prestigious. Mr. Morse suggested you check for an earlier shot gun start to cut costs a bit. Ms. Prebis will inquire about that.
- 3. Earth Day Mon, April 22, 2024. We will be opening and planting our Community Garden with flowers again this year. We are also looking to piggyback on the US Earth Day initiative, "plastics vs. planet." P & R will be coming up with ideas how to campaign and get this out to the residents. Park Board will also contact Ms. Prebis is they have any ideas.
- 4. <u>UFK Food Truck Festival</u> Sat, April 27, 2024. We had out first committee meeting about this last week. Ms. Getty has 10 food trucks booked already. We are looking into the band and a speaker. It was suggested a Zydeco (New Orleans band) and the North Penn Ambassadors (HS kids that do things for the community.) Ms. Prebis will be looking into both as well as brining in an alcohol vendor. She will be setting up a discussion with township staff to discuss this.
- 5. <u>Senior Games 2024</u> Mon, May 6 Fri, May 10, 2024. We are holding the Basketball Foul shooting and Hot shot at Upper Gwynedd on Thursday, May 8 and need 5-6 volunteers for this event. The event starts at 6pm.

7. **Other Business**

- Mr. Morse asked about how pickleball did this season. It was reported they were doing very well and both the "meet up group" and the "non meet up group" was respectful of each other. He reported seeing no problems at the courts.
