- Technology: Upgrade of technology in Codes, Public Works, Finance, and the Township GIS system.
- Codes: tracking of violations, review of codes, illegal signs, and staff time to comply with Right-to-Know requests
- Planning: Development and consideration to infrastructure and develop a vision for the Township
- Facilities and Township Property/Other: space for equipment and recreation programs and explore insurance options

The Board and Township staff engaged in discussion on each of the issues and discussed the goals and objectives for addressing these issues.
