# 2. Approval of Minutes from the meeting held on Monday, November 3, 2020

### 6. **New Business**

#### A. The plan for 2021

Ms. Prebis stated that we are going to try to run events like normal (with safety precautions put in place.) Park and Rec is planning on programming normally. At the moment, everything is virtual, but we will re-visit this at the end of the week. Ms. Capozzi also spoke of programs we have scheduled for winter/spring.

#### B. Dates for events 2021

A flier was made for all the important dates for 2021. It was sent to the board and is attached in these minutes.

## C. Capital Projects for 2021.

Ms. Prebis went over all the capital project that were approved for 2021. These include: tennis court crack repair, a tractor purchase (split with WWTA,) a mower purchase, lighting for center street, landscaping the Sumneytown Bridge, the purchase of a plow as well as putting a utility bed on the back on one of the Park and Rec trucks. Mr. Nagele asked about how the bidding works and do we have a specific place we purchase mowers and tractors. Ms. Prebis explained the government process and the COSTARS program.

#### 7. Other Business

#### A. Trails

Ms. Prebis spoke about the Powerline Trail being halted due to PECO and mentioned she sent and application and check to PECO to get this process moving. She also spoke about the advertising for the RFP for the Liberty Bell trail and the RFP's are due on January 12. From there UG and Hatfield Township will proceed with the interview process.

#### B. Mural

Mr. Nagele asked about the mural and how that was coming along. Ms. Capozzi mentioned we ordered the supplies for the student and the student has started. We are hoping to get this completed in the Spring.

## C. Indiana Gnomes

Mr. Nagele mentioned this project and how much he enjoyed seeing where the Gnome would be next. He also mentioning the online craft looked great. Ms. Johnson said these virtual offerings should be done more because people are stuck in their homes during COVID-19.

## D. Adopt a family

Mr. Zumpino wanted to thank everyone who donated for this family and thought it was an amazing idea. Ms. Prebis and Ms. Capozzi gave a little background of how we found the family and Ms. Prebis will send the "thank you" email to the Park Board.

#### E. Spotted Lanternfly

Mr. Lippert asked if anyone has noticed a decrease in them since we put out our campaign on squashing these. Both Ms. Capozzi and Ms. Prebis did not receive any complaints about them this year. Ms. Prebis also mentioned that Park and Rec does not spray for Spotted Lanternfly but reports it to the Penn State Extension, which she did not have to do in 2020.

Mr. Nagele asked for any further questions or comments. Upon hearing none, Ms. Johnson made a motion to adjourn which was seconded by Mr. Zumpino and passed unanimously.
