### **Executive Summary**

#### 1. Initiation

In 2022, the Pennsylvania Department of Community & Economic Development (DCED) began a project to assess the existing and proposed fire station locations as requested by Upper Gwynedd Twp.

#### 2. Purpose

Municipalities should periodically review the fire services that they are responsible to deliver under the municipal laws of the Commonwealth. The purpose should be to make sure that fire protection is being delivered in a competent, prompt, professional manner with the needed resources, operational efficiencies, and management and that citizens expectations are met.

This assessment is intended to provide the municipalities with an overview of fire protection to ensure that they can evaluate these findings to provide services effectively and efficiently to the residents of both municipalities.

#### 3. Process Used in the Study

To understand and evaluate these issues, the principal approaches utilized in this study included the following:

- Meetings and Road Tours with the Municipal Officials of Upper Gwynedd.
- Site visit to the Fire Station and interactions with available members.
- Interaction via email and phone to conduct follow ups.
- Promulgation of general questionnaires and data collection. This was based on the scope of services that was requested by Upper Gwynedd from the Center for Local Government Services (CLGS). It was then distributed to the parties providing Fire Protection to the Township. The documents were returned and used to gain further insight to the services provided.
- Methodology as noted.

#### 4. Overview

Upper Gwynedd Municipal Officials and Upper Gwynedd Fire Department (UGFD). asked that the following be analyzed:

- Evaluation of current fire station location at 660 Garfield Ave.
- Evaluation of 3 additional proposed fire station locations.
  - o Allentown Rd. & Sumneytown Rd. West Corner. Parcel 560000112003
  - o Allentown Rd. & Sumneytown Rd. East Corner. Parcel 560008317105
  - o 1671 West Point Pike. Parcel 560002557006



#### 5. Observations

Although the core of this report is evaluation of the topics above, given the contemporary issues confronting the Pennsylvania Fire Service at large, due diligence requires to recommend that Upper Gwynedd Township should consider communicating with neighboring municipalities to see if there is an interest in exploring regionalization of Fire Protection before investing in any fire station planning and construction related activity.

#### 6. Recommendations

Major Recommendations		
1	Upper Gwynedd Township should consider communicating with neighboring municipalities to see if there is an interest in exploring regionalization of Fire Protection before investing in any fire station related planning and construction activity. Consult the Intergovernmental Cooperation Handbook published by the Pennsylvania Department of Community & Economic Development regarding sharing of Fire Services.	
2	Disregard the West Point Pike location as it lies in the FEMA Floodplain	
3	Evaluation of each of the proposed locations based upon the noted methodologies reveals that the optimum site for a fire station would be the <u>West</u> Corner of Allentown Road and Sumneytown Pike. This 11.8-acre location, also noted as Parcel 560000112003, is zoned R-1, this would require either a Zoning Map Amendment by the Upper Gwynedd Commissioners or Use Variance by the Zoning Hearing Board. The location is optimum as a nearly centrally located location for response efficiency and geographical coverage. The size of the parcel will allow for design, planning and construction of a contemporary fire station for the future needs and demands of the community of Upper Gwynedd.	



### Methodology

Methods used to evaluate the optimum location out of the 4 proposed by the municipality and the fire department included:

- Site visit to each location
- Analysis of parcel zoning.

- ➤ Upper Gwynedd, with 2,112 persons per sq. mile, falls into the Urban Demand Zone.
- ➤ Evaluation of response time specifics, with UGFD provided data, shows compliance in that specific area as noted in the response time analysis. The objective percentage could not be analyzed with data provided.
- > Staffing, on the face of it, does not comply, as there was no ability to analyze this area under table note b.
- Insurance Services Organization (ISO) Criteria for Deployment Analysis of Companies: To reduce property damage from a fire, firefighters need to get to the scene quickly. Therefore, ISO evaluates the deployment of fire stations in each community.
  - For full credit in the Fire Suppression Rating Schedule (FSRS), the fire protection area with residential and commercial properties should have a first-due engine company within 1.5 road miles and a ladder service company within 2.5 road miles.
- Location Radius Analysis: Radius Analysis of 1, 2- and 3-mile increments.
- Service Demand by Geography/Box Areas: This evaluation could not be made, as the UGFD did not have a complete data set.

Response time begins upon completion of the dispatch notification and ends at the time interval shown in the table.



### **Municipal Overview**

#### Upper Gwynedd Township, Montgomery County PA

Upper Gwynedd Township is a township in Montgomery County, Pennsylvania. The population was 17,107. North Wales Borough is surrounded by Upper Gwynedd Township on all sides, and many homes and businesses with North Wales addresses are actually in Upper Gwynedd. Many properties with Lansdale addresses are in Upper Gwynedd as well. It is part of the North Penn Valley region that is centered around the B0orough of Lansdale.

Gwynedd was founded in 1698 by Welsh Quakers. The township was then split into Lower Gwynedd and Upper Gwynedd in 1891. The name Gwynedd means "Fair Land" in Welsh.

The township is so named because it was originally settled largely by migrants from <u>Gwynedd</u> and other parts of <u>North Wales</u> in the 17th and 18th centuries. For several generations the main language used in the township was <u>Welsh</u>.













### **Upper Gwynedd Street Map**

#### **Existing Fire Station Details**

In-person observations of Station 80 show that it appears to be well-maintained considering its age of specific facilities. In addition to the station visits, the company was given a Facility Questionnaire to fill out. Both reveal that the facility, while not originally designed for modern fire station amenities, the UGFD has attempted to integrate them to the best of their abilities.


The current fire station has sleeping facilities to utilize "duty crews" during overnight hours. The usage of the duty crew concept allows for volunteer to improve turnout times and total response times as the initial response crews are located at the station when the call for service is dispatched.


The location of the current fire station reveals Station 80 was founded in the long-established Village of West Point, as residents saw the need for community fire protection in the early 20<sup>th</sup> Century.


When this organization was established, there was no consideration of response times, as it is evaluated contemporarily. The response to the fire calls in the volunteer fire service also has to account for the response from the individual homes of the volunteers to the fire station.











**Busiest Month: March: 217 Runs** 








#### **Response Times**








NFPA 1720 9 Minute Response – Reachable Streets


ISO 1.5 Miles Engine Company - Reachable Streets


ISO 2.5 Miles Ladder Company - Reachable Streets


ISO 1.5 Mile Engine Company & 2.5 Miles Ladder Company - Overview







1-2-3 Mile Radius






Allentown Road and Sumneytown Pike. East and West Corners NFPA 1720 9 Minute Response – Reachable Streets






Allentown Road and Sumneytown Pike. East and West Corners ISO Engine Company 1.5 Miles






Allentown Road and Sumneytown Pike. East and West Corners ISO Ladder Company 2.5 Miles






